### **Terms and Conditions:**

Class fees are \$80 per term for Pure Dance and Fun, \$85 per term for 45 minutes classes (Pre-Primary Ballet, Beginner Tap/ Junior Jazz); \$100 per term for hour classes (Primary, Grade 1 and Grade 2 Ballet). Additionally, there is a \$15 enrolment fee, payable once per year, on enrolment. Please speak to the **PURE DANCE** teachers to organise alternative payment arrangements if your circumstances inhibit the payment of fees. Refunds will only be considered in very special circumstances.

Parents are welcome to wait in the waiting area in the church hall, and there is access to toilet facilities. There will be an open lesson once or twice each term when parents will be welcome to view the lesson and observe their child's participation and progress.

All care will be taken by the teachers of **PURE DANCE**, but no responsibility will be taken for injury or loss to person or property whilst in class or on the premises. Teachers will seek medical attention for your child immediately if needed. To provide adequate dance tuition it may be necessary for dance teachers to guide student movement, which may require physical contact. Photographs and video footage may be taken by Dance Teachers of students during class and used for promotional purposes. Photographs or videos must not be taken by parents during class time. Children must be supervised out of class hours by parents/guardians.

It is expected that students and parents will treat all teachers, students and parents with respect.
